Report to Parish Council on Neighbourhood Development Plan (NDP) January 2020

- **Current position:**
 - AECOM advised that they are currently working on the Site Assessment Assistance package, and it is nearing checking stage for the initial draft report.
 - AECOM advised that the site visits took place, and they are aiming to issue the draft report to the NDP in February 2020.
 - The NDP carried out health and wellbeing integration sessions during the December and January meetings as a reflection exercise to ensure that proposed planning policies have a positive benefit on health and wellbeing of the community at the core of the benefits that would be received. This current focus is to make sure that the NDP has been considered from as many perspectives as possible, and that the proposed policies should have the intended outcome of addressing and improving the local area for the benefit of the inhabitants and environment, should they be implemented.
 - The NDP are also discussing how to encourage more community involvement, and whether promoting the health and wellbeing benefits that could result from the proposed NDP is a better angle to promote, as this is the aim of planning policies and any land allocations, to result in an improvement of the local area, facilities, and quality of life to improve the health and wellbeing of those who live, work and visit this Parish.

- **NDP's responses to various EHDC Consultations**
 - The NDP have still not yet received feedback on our response to EHDC's Regulation 18 Consultation submitted in March 2019.
 - The NDP submitted a response to EHDC's 'Liphook Conservation Area Character Appraisal and Management Plan - Community Consultation'. No feedback has been received to date.
 - The NDP have also submitted a response to EHDC's Large Development Sites Consultation, no feedback has been received to date.

- **Next steps:**
 - The NDP are continuing to communicate with AECOM for the SEA, HRA and Sites Assessment assistance.
 - The NDP are to continue to communicate with EHDC and SDNPA regarding the draft planning policies to date for assistance with next steps forward.

- **NDP Members:**
 - The NDP sadly announce that Cllr Rebecca Standish has stood down from her position on the SG due to moving away from the area. The NDP would like to thank Cllr Standish for all her hard work, dedication, drive and continuous support of the NDP and its members.
 - The NDP are aware that a new administrator has been appointed and look forward to her commencing on the 28th January 2020.
 - SG currently has 7 members, which includes the 2 Parish Councillors.
 - The SG are actively recruiting for more members to assist with the workload, and would appreciate any support to obtain enthusiastic and interested people to join our team.
 - The SG have asked the current Working Party members whether any would like to become Steering Group members. The applications are being considered.

- The SG will continue to assess applications to ensure potential members have an existing positive involvement and engagement with the community and facilities of the Parish.
